Music Video. Before they leave for Europe, 311 will begin production on their latest music video entitled "Transistor." Current plans are to release the video to MTV in July.

This month concludes the second part in the series entitled A Day in the Life of Adam Raspler (311's Manager). Again, it is based on events that transpired on April 2<sup>nd</sup> of this year:

11:00 AM Yonnie (311's tour manager) enters the office (he works with me when the band is off the road). Right now Yonnie is busy coordinating the budget, production rider & crew for the upcoming tour. This year's production will be massive. 311 & crew will total 33 people on the road in (3) 45-ft buses and (4) 18-wheeler semitrucks. We will have a massive sound and light system totally state of the art.

11:30 - 1:00 PM Various phone conversations with...

- BMI (311's performance rights organization) regarding publishing royalties.
- Surfrider regarding upcoming compilation CD that will include 311's "Hydroponic" to benefit Surfrider Foundation (all proceeds go to clean up the oceans).
- Neal Levin & Co (311's accounting firm) regarding band's tax returns & insurance for upcoming European tour. Set up meeting to discuss expense budget for upcoming US tour.
- 4) David Codikow (311 Attorney) regarding outstanding legal issues, i.e. producer agreement, publishing deals, synch licenses, copyright & trademark registration & protection, etc...
- Harvey Schwartz (311 A&R rep from Capricorn Records) regarding marketing plan for upcoming record. Arrange meetings in New York and Nashville for late April.

1:30 PM Meeting at Pawn Shop Press to discuss album artwork & website design. The website is almost finished (check it out soon at www.311music.com).

2:30 PM Meeting with Neal Levin (311's accountant) to discuss & analyze a recent royalty statement from Polygram distribution.

3:30 PM Go to studio to meet with band. Discuss touring plans, new mail-order merchandise catalog, sound-scan sales report, website, album artwork, upcoming press schedule (includes features in *Modern Drummer, Guitar World*, etc.), and try to finalize the album title.

4:30 PM Meeting with Danny Goldberg (President of Mercury Records) at the studio. Discuss release dates, marketing plan, packaging, etc.

5:30 PM Head back to the office. Make arrangements for Nick's upcoming birthday (April 12<sup>th</sup>). Dinner for 30 people at a restaurant/club in LA.

6:00 PM Review the latest fax and voice mail messages. Make some final calls, type and fax letters of correspondence to Capricorn, etc.. Wind down... take another listen to the DAT and lose myself in the new sounds of 311's 4<sup>th</sup> record... I can't wait to share it with the world. PEACE.
